# Who are we looking for?

### Role's purpose

To advise the board of trustees, ensuring the voice and views of children and young people is at the heart of our governance decision-making.


This role joins our other board advisors, who attend all board meetings and can participate in full, without the specific responsibilities of trustees.

All board members are expected to have:

- a commitment to Magic Breakfast's vision and mission
- willingness to devote the time and effort needed to fulfil the role

- integrity
- · a willingness to speak their mind
- an ability to work effectively as a member of a team and to take decisions for the good of Magic Breakfast.

This role forms part of our effort to build a diverse and skilled board with relevant experience and understanding relating to Magic Breakfast. We offer support and training to enable individuals to understand the role of charities, trustees, and world of work.



## **Expectations of Youth board advisor**

- Youth board advisors will be supported to complete an induction programme with Magic Breakfast in their first six to nine months.
- Youth board advisors are expected to attend all board meetings. Board meetings are held four times a year and no longer than three hours in duration (evenings). One meeting each year is allotted to strategic planning and takes place over a full away day.
- Papers are distributed one week in advance of meetings and should be read prior to the meeting. A meeting with a member of the board or executive team before the meeting to discuss the papers is arranged.
- Youth board advisors are welcome to join committee meetings if they are interested in learning about particular aspects of the charity.

# Role description

#### Main tasks

With other board members:

**Strategy**: to provide your insight to the board in developing and reviewing Magic Breakfast's strategy.

**Support**: to support the chief executive and executive team in delivering the vision and mission of the organisation.

#### Main duties

## Providing strategic leadership

- Consider the organisation as a whole and its beneficiaries
- Reflect the organisation's vision and principles, strategy and major policies
- Reflect the organisation's values
- Input your perspective and insights when the board develops and reviews policies and practices

- Attend meetings of the board members
- Play your part and help the trustees safeguard the good name and values of Magic Breakfast
- Be an active member of the board
- Maintain constructive relationships with senior managerial staff
- Take part in training and development sessions provided for the benefit of the board
- Use your skills, knowledge or experience to help the board members reach sound decisions.
  This may involve scrutinising board papers, leading discussions, focusing on key issues, or providing advice and guidance on new initiatives.

# Commitment to equity, diversity and inclusion (EDI)

As set out in our EDI mission statement, Magic Breakfast is committed to equity, diversity, and inclusion (EDI). Everyone at Magic Breakfast has the responsibility to be open and to create and sustain an inclusive environment. This includes and applies to board members, staff, volunteers, partners, and suppliers. In building and leveraging a diverse and inclusive board of trustees we will ensure our staff, the partners and volunteers we work with and children and young people we serve are able to actively engage with and access the charity and its services without barrier.

## Safeguarding children and young people

Magic Breakfast is committed to safeguarding and promoting the welfare of children and young people and expects all board members to share this commitment. All board members and staff are required to undertake a standard criminal record (DBS/PVG) check.

#### Terms of appointment

This role is unpaid but we recognise the barriers that costs may introduce. Board members can claim travel, accommodation, childcare, Wi-Fi, mobile phone, and other costs incurred by them in attending Board meetings, committee meetings, or any meeting in connection with Magic Breakfast's work.

#### Time commitment

Youth board advisors are expected to attend each quarterly Board meeting. Ad hoc meetings are called to discuss pressing topics, but on average trustees spend no more than 6-8 hours per month on preparation, formal and ad hoc meetings. Whilst attendance at Board meetings in person would be preferred, other meetings can be attended virtually via Zoom/Teams. Reasonable expenses relating to travel on Magic Breakfast business will be reimbursed.
